The answering service,meeting lists,books,literature and so forth.A.A. literature clearly states that purpose."Self Supporting Through Our Own Means" & "A.A. Where Money and Spiritualality Mix" and "The Group" pamphlet.If a person goes to an A.A. meeting and puts a contribution into the basket as it is passed,then they feel that they are contributing to A.A.services,not for funding dances or picnics or other such functions.The money is to be given back to A.A. through the various levels of A.A. as a whole.

The donations the groups should make should go through the A.A. service structure, i.e., Intergroup, District, Area, and GSO. It was then discussed that it's not so much as to where it is going as to where it is coming from, as we could be breaking a couple of A.A. Traditions. The discussion continued that the raffles are a good way to raise money to puchase something to raffle off at the picinics to the members there, but as it states in the pamphlet "The Group" non A.A. people may attend our functions, as it could benefit them, but they can't join A.A. functions as a member, but we should not seek out donations from them either.

There was much discussion about this practice of selling A.A. function tickets to outsiders. It was decided that the Serenity Picnic is an A.A. function, but outsiders may attend. The tickets sold for the camping trip coming up in July will have the winners announced at the Serenity Picnic. A motion was then made to suggest that the members who sell the tickets for the Serenity Picnic drawing should only sell to other A.A members. A second was also made in support of the motion, and the motion passed. So the tickets that are going up for sale in May for the camping trip should be sold to A.A. members only. The Daily number drawing will be on July 9th the day of the Serenity Picnic.

The only other new business brought up was by Bob S. DCM as a reminder to also announce that District 41 will be holding a workshop the 1st Sunday in May- May 7th at HGA at 5:p.m.The workshop will be for all group GSR's and will cover the following 2 topics: Where do we go from here & What is a GSR?
