

District 41 Minutes for February 2006

Meeting held February 5, 2006 at

Hiram G. Andrews at 6:00 p.m.

DCM: Bob S. opened the meeting with the Serenity Prayer. Bob also gave a brief rundown of the January meeting held at Good Sam's meeting room for the final time, January 5, 2006. The summary follows: The district 41 meeting was not held due to lack of representation from groups in District 41. Only the DCM, the Alternate DCM and the Treasurer were in attendance. Treatment Facilities Coordinator: Karen S. Gave a report as follows
Currently we have assembled a committee of men & women from District 41. They have delivered Alcoholics Anonymous books & tapes to the following locations: White Deer Run, men's & women's New Visions and the Hiram G. Andrews Rehabilitation Center. They would like to reach Twin Lakes. Twin Lakes has stopped meetings from going into that facility. Currently the White Deer run women's house has agreed to allow committee members to bring female speakers into the facility from District 41 having at least 2 years sobriety, one Monday per month starting in February 2006. They need to submit a 6 month calendar with the speakers to the Facility director. Patricia and Karen are working on this at this time.

GSR Reports: Phil K. Attitude Adjustment Group. The meetings have dropped off to about 12-15 on average. They still get newcomers approximately 6 in the past month and have added 2 new home group members in January and now have at least 10 active. Still making donations to Intergroup, District 41, Area 60 and GSO.

Bill G. EZDZIT Group. The meeting is still status Quo. Attendance fluctuates, money is doing ok, have 3 home group members and still are having all speaker meetings.

DCM Report: Bob S. Bob attended the 1st 1/4ly meeting in Butler on January 15, 2006. The report is attached to these minutes. Also stated that the Seeds of Service theme will be "Are we supporting ourselves?" Then passed out A.A. Corrections Prerelease forms to be made available to all home group so any home group member or any A.A. may register to be a contact.

This years themes for the conference will be Sponsorship, Service and Self Support in a Changing World.

Bill G. made a motion to accept the DCM report, Karen 2nded, the motion passed. Also there will be a non Area 60 sponsored DOS this February in Trenton PA on February 18, 2006 all are welcome.

Old Business: No contact with District 17 on their DOS as of yet, but we will provide panel members for the event if needed.

New Business: Karen S. made a motion to set up a budget for the Treatment Facilities Committee. The budget would be to purchase A.A. books, literature, workbooks, and appropriate tapes to take into the facilities. Also needed a sum of \$48.50 for books already purchased. The \$48.50 sum was approved and Bill G. made a motion to table the budget talk till the next meeting. Phil K 2nded the motion. The motion passed. Bob S. also suggested that they could ask meetings if they could set coffee cans out at various meetings as a way to also collect money.

Bill G. made a motion to adjourn the meeting, Karen S. 2nded the motion passed.

The meeting closed with the Responsibility Pledge.
